

## 2011 Administrative Cost Recovery Worksheet

Those Users who are classified as Large Commercial-Industrial Users are subject to Administrative Cost Recovery (ACR) Charges. The ACR charge has two components, the Minimum Pretreatment Requirement (MPR) charges and the User Charge Verification (UCV) charges.

**Minimum Pretreatment Requirement (MPR) Charges** are applicable only to Significant Industrial Users (SIU) and represent the charges for annual account administration, review of mandatory reports and charges for annual inspection and sampling of SIUs under the District's Pretreatment Program, and shall be recovered according to the following schedule for 2011:

**User Charge Verification (UCV) Charges** represent the charges for annual account administration, review of User Charge reports, and sampling of Large Commercial-Industrial Users (LCIU) and shall be recovered according to the following schedule for 2011:
